Terms

For purposes of this agreement, the terms "contract" and "agreement" are interchangeable. For purposes of this agreement, "G/guests" is strictly limited to those who are lawful invitees of VPT.

Agreement

I accept full responsibility and liability for any real property damage or loss or personal injury I cause, while holding VPT harmless in case of injury, death or economic loss. This agreement is binding unless I contact VPT at least thirty days prior to arrival.

Please see the Cancellation Policy in the Rental Policies & Guidelines. Cancellation of a reservation of the whole property must be at least 60 days before the scheduled event; other cancellations are needed at least 30 days prior.

Reservations may be made up to one year in advance. Rates quoted by telephone or in writing become binding upon receipt and signature of this Rental Agreement plus deposit. When VPT receives this agreement, both parties are bound by its terms.

A deposit of \$100.00 is required at time of reservation for Ahimsa Lodge, Swann-Corrie House, A.J. Muste Center, Chuck's Cabin, or the Yurt. For groups renting all buildings, the deposit is \$400.00. Deposits are forfeited if cancellation is made with less than one month's notice.

Your deposit will be reimbursed within two weeks of your stay if the spaces you used are left as you found them, are left clean and all non-recyclables were taken with you at departure.
